

1.1 I am the Director-General of the Department of Mineral

1.2 I am duly authorised to depose to this answering affidavit on behalf of the First Respondent (the Minister of Mineral Resources, in her official capacity). I shall refer to the First Respondent as "the Minister".

1.3 The facts contained herein fall within my personal knowledge, except where appears otherwise from the context, and are true and correct.

1.4 To the extent that I make submissions of a legal nature herein, I do so on the strength of legal advice.

1.5 The allegations contained in the founding affidavit are for the most part common cause between the parties. I am accordingly advised that it is unnecessary for the determination of the matter to deal *seriatim* with such allegations. I shall deal with the allegations contained in the founding affidavit only insofar as the same are disputed.

AD FOUNDING AFFIDAVIT:

2.

AD PARAGRAPHS 18.2 – 18.3 THEREOF:

2.1 In her answer to Parliamentary Question 1409 dated 26 May 2011, (Annexure "JFKD9"), the Minister stated that:

2.1.1 the task team is chaired by the Director-General of the Department of Mineral Resources, and is comprised of Deputy Directors-General of the Department of Mineral Resources, the Department of Science and Technology, the Department of Trade and Industry, and the CEO of the Petroleum Agency of South Africa;

2.1.2 the task team is supported by a working group comprising of representatives from the Petroleum Agency of South Africa, the Council for Geosciences, and the Council for Scientific and Industrial Research.

2.2 I attach hereto as Annexure "TR1" the terms of reference of

the task team. As appears from the terms of reference:

2.2.1 the task team is chaired by the Director-General of the Department of Mineral Resources;

2.2.2 the task team is comprised of representatives of:

- (a) the Department of Mineral Resources;
- (b) the Petroleum Agency of South Africa;
- (c) the Department of Energy;
- (d) the Department of Science and Technology;
- (e) the Department of Environmental Affairs;
- (f) the Department of Water Affairs;
- (g) the Department of Economic Development;
- (h) the Department of Trade and Industry;

2.2.3 the working group is comprised of representatives of:

- (a) the Petroleum Agency of South Africa;
- (b) the Council for Geosciences;
- (c) the Council for Scientific and Industrial Research;
- (d) the Department of Water Affairs.

2.3 The factual position regarding the membership of the task team and the working group is as set out in the terms of reference (Annexure "TR1").

3.

AD PARAGRAPH 40 THEREOF:

3.1 It is correct that the task team does not have any members from the Department of Agriculture. Regard being had to what is stated in paragraph 2.2.2 above, the task team does have members from the Department of Water Affairs and the Department of Environmental Affairs.

3.2 Whilst the task team does not have any members from the Department of Agriculture, the report of the task team will be presented to Cabinet prior to its release into the public domain. The Department of Agriculture will accordingly have input into the report of the task team.

4.

AD PARAGRAPH 41 THEREOF:

It is denied that *"the task team's report would have to be considered tainted by bias"*. The companies that have applied for fracking-related exploration licences (namely Shell Exploration Company B.V., Bundu Oil & Gas (Pty) Ltd and Falcon Oil & Gas Ltd) have not been allowed to engage with the task team as part of the working group's and task team's research.

5.

AD PARAGRAPH 45 THEREOF:

It is not the intention that *"the public and parties promoting the public interest should be denied access to information which has truly significant*

environmental, economic and public health implications". The Minister's position is rather (as appears from the extract from the Cape Argus, 19 August 2011, Annexure "JFKD19") that "government first needed to be informed about fracking and to understand it before engaging in a public participation process that would precede its making a decision. The time will come when we will engage with everyone".

RELIEF CLAIMED:

Prayers 1.1 – 1.3 of the notice of motion:

6.

6.1 The terms of reference relating to the research to be conducted by the task team and the working group on fracking are attached hereto as Annexure "TR1".

6.2 The identities and qualifications of the members of the working group (save for the qualifications of 4 members) are attached hereto as Annexure "TR2". The qualifications of these 4 members will be furnished to the Applicant prior to the hearing of the matter.



6.3 The task team is comprised of the representatives referred to in paragraph 2.2.2 above. As the information officer of the Department of Mineral Resources, I do not have a record of the qualifications of the representatives of the government departments referred to in paragraphs 2.2(c) – (h). I attach hereto my qualifications as Annexure “TR3”.

Prayers 1.6 – 1.7 of the notice of motion:

7.

7.1 It is anticipated that the task team’s report will be finalised by 31 March 2012. Thereafter the task team’s report will be presented to Cabinet (by way of going through the Cabinet process) prior to its release into the public domain. The duration of the Cabinet process is not within the control of the Department of Mineral Resources. The estimated or expected release date of the task team’s report can accordingly not be given.

7.2 The working group’s and task team’s reports to date have not been furnished to any entity. Nor will such reports be furnished to any entity prior to the finalisation of the report, and the



release of the report into the public domain after it has been presented to Cabinet (by way of going through the Cabinet process).

Prayer 1.8 of the notice of motion:

The correspondence referred to in prayer 1.8 of the notice of motion (together with an index) is attached hereto as Annexure "TR4".

Prayer 1.4 of the notice of motion:

9.1 The Applicant seeks by way of prayer 1.4 of the notice of motion the "*(m)inutes of all working group and task team meetings*".

9.2 Section 44(1)(a)(ii) of the Promotion of Access to Information Act, No. 2 of 2002 ("PAIA"), provides as follows:

"44. Operations of public bodies.- (1) Subject to



subsections (3) and (4), the information officer of a public body may refuse a request for access to a record of the body -

(a) if the record contains -

(i) ...; or

(ii) an account of a consultation, discussion or deliberation that has occurred, including, but not limited to, minutes of a meeting,

for the purpose of assisting to formulate a policy or take a decision in the exercise of a power or performance of a duty conferred or imposed by law;"

9.3 In the light of the provisions of section 44(1)(a)(ii) of PAIA, it is submitted that the Applicant is not entitled to an order in terms of prayer 1.4 of the notice of motion by way of access to the minutes of working group and task team meetings. Legal argument will be presented to the Honourable Court in this regard at the hearing of the matter.

Prayer 1.5 of the notice of motion:

10.1 By way of prayer 1.5 of the notice of motion, the Applicant seeks "*(a) copy of the most recent version of the reports of the working group and task team, irrespective of whether or not they are currently in draft form or whether they have already been finalised*".

10.2 Section 44(1)(a)(i) of PAIA provides as follows:

"44. Operations of public bodies – (1) Subject to subsections (3) and (4), the information officer of a public body may refuse a request for access to a record of the body -

- 10.3 In the light of the provisions of section 44(1)(a)(i) of PAIA, it is submitted that the Applicant is not entitled to an order in terms of prayer 1.5 of the notice of motion by way of access to the reports of the working group and task team (which are currently in draft form), being reports obtained or prepared for the purpose of assisting to formulate a policy or take a decision in the exercise of a power or performance of a duty conferred by law on fracking. Legal argument will be presented to the Honourable Court in this regard at the hearing of the matter.

Prayer 1.9 of the notice of motion:

- 11.1 By way of prayer 1.9 of the notice of motion, the Applicant



seeks "(a)ll research documents (reports, studies, commentaries, academic papers and the like) that relate to fracking and which have been, or may be, used as part of the working group's and task team's research, and in particular, any such documentation that may have been furnished to the members of the working group or task team by Shell, Bundu and Falcon."

- 11.2 It is submitted that in the light of section 44(1)(a)(i) of PAIA (as quoted in paragraph 10.2 above), the Applicant is not entitled to an order in terms of prayer 1.9 of the notice of motion by way of access to the research documents referred to in such prayer, being documents obtained or prepared for the purpose of assisting to formulate a policy or take a decision in the exercise of a power or performance of a duty on fracking. Legal argument will be presented to the Honourable Court in this regard at the hearing of the matter.

WHEREFORE the Respondents pray that the application be dismissed in respect of prayers 1.4, 1.5 and 1.9 of the notice of motion, each party to bear its own costs of the application.

TERMS OF REFERENCE

1. PURPOSE

The purpose of the Task Team shall be to investigate the full environmental, social, economic and legal implications of hydraulic fracturing as a technique for the exploration for, and production of oil and gas in South Africa, and to submit a report hereon for consideration by the Minister of Mineral Resources.

2. AUTHORITY OF THE TASK TEAM

- 2.1 The Task Team shall be advised by a Working Group, and such other ad hoc committee as it may deem necessary to constitute.
- 2.2 All policy decisions of the Task Team, excluding those that are for the administration of the functions of the Task Team, shall constitute recommendations for the Minister's final decision.

3. COMPOSITION OF THE TASK TEAM

3.1 The Chairperson

The Task Team shall be chaired by the Director General of the Department of Mineral Resources or such other official of the Department, or State Owned Entity (SOE), as the Minister of Mineral Resources may appoint.

3.2 Membership

The membership of the Task Team shall be made up of representatives of the following government departments and SOEs:

- Department of Mineral Resources

- Petroleum Agency SA (PASA)
- Department of Energy
- Department of Science and Technology
- Department of Environmental Affairs
- Department of Water Affairs
- Department of Economic Development
- Department of Trade and Industry

3.3 Working Group

The **Working Group (WG)** will be chaired by the Chief Executive Officer of PASA and will comprise representatives from the following organisations:

- PASA (DMR)
- CGS (DMR)
- CSIR (DST)
- Department of Water Affairs

4. RESPONSIBILITIES

The Task Team, with the assistance of the Working Group, will investigate -

- 4.1 the technical aspects of hydraulic fracturing (HF) with respect to conventional petroleum, coalbed methane and shale;
- 4.2 possible environmental and social implications of hydraulic fracturing and related activities for the different hydrocarbon play types, including but not limited to
 - 4.2.1 land use
 - 4.2.2 water use
 - 4.2.3 water pollution OR aquifer contamination
 - 4.2.4 noise / dust pollution
- 4.3 the existing regulatory framework to identify any shortfall or omission with regard to proposed activities;
- 4.4 the estimates of the (unexplored) hydrocarbon resource and any constraints on these;
- 4.5 the implications for South Africa's energy security;
- 4.6 the economic implications of either a ban, moratorium or stringent environmental regulatory measures on Hydraulic Fracturing (HF);

- 4.7 Infrastructure and market limitations for gas and its effect on viability of the resource; and
- 4.8 Implications for Astronomy Research projects for South Africa.

Mthozami Xiphu is the Chief Executive Officer of Petroleum Agency SA, which is responsible for the promotion, licensing and regulation of petroleum exploration and production activities on- and offshore South Africa. He currently serves as a member of the Task Team and as the Chairperson of the Working Group of the Task team. He has BA (1983) and MA (1985) degrees from Howard University, Washington DC, USA, and a B Juris (1995) degree from the University of Port Elizabeth. He was translated to the Directorate Geohydrology when the Geological Survey relocated to the Department of Water Affairs in 1977. After completion of the Karoo investigations he moved to the West Coast (Vanrhynsdorp and Lamberts Bay area) doing groundwater mapping, development and aquifer-evaluations. After completing a full-M.Sc. (Geohydrology) at the University of the Orange-Free State, Bloemfontein between 1981 and 1987, he was appointed as Chief Hydrologist in the Kuruman Office, Northern Cape Region. 

FOUNDING STATEMENT FOR THE GRAAFF REINET SHALE-GAS COMMUNITY FORUM

PREAMBLE

We the community of Graaff Reinet, coming from the sector of the predominantly historically disadvantaged population faced by unemployment, high unemployment and daily hardships have gathered today, on 19 June 2011, to make our view known on the subject of energy groups? applications to study the feasibility of extracting natural gas from shell rocks formations beneath the Karoo area.

We meet here today as representatives of each and every community based organization, having received mandate from each of our organization and after extensive and intensive discussions on the subject of shale gas, to tell the people of South Africa that the majority of the people of Graaff Reinet have mandated us to form and launch the Graaff Reinet Shale-Gas Forum.

OUR MESSAGE TO SOUTH AFRICA

We of the Graaff Reinet Shale-Gas Community Forum are mandated by the communities we represent to tell our Government, the stake-holders to the shale gas opportunity, namely industry, interest groups and communities affected as well as the people of South Africa at large that this is our Karoo too and that contrary to what has been said in the media and on other platforms, we had not mandated anyone to represent us on the said opportunity.

We are here today not just to reclaim what also belongs to us, our Karoo, but to let the people of our South Africa know that the opinions expressed by the so called representatives of the Karoo communities are certainly not a reflection of the position of the majority of the population represented by our Forum. THE ISSUE AT HAND

Several companies, including oil major Royal Dutch Shell and petrochemicals group Sasol are queuing for rights to explore for shale gas in the Karoo. Indications had been found that there is abundance of natural gas in the area, but there is great uncertainty where the gas is, whether it could flow and whether it could be produced economically. The purpose of exploration is to establish if gas would flow and this is done through a technique known as fracking or hydraulic fracturing. It is a technique that involves the injection of water, sand and other fluids at very high pressure into the rock formation, creating cracks that would allow the natural gas to flow.

There has been a public outcry over Shell's and other companies' applications and the opposition to hydraulic fracturing is mainly centered on the following three areas:

- A. Huge amount of water are required for both the drilling and hydraulic fracturing and at the same time it is a known fact that Karoo is semi-arid.
- B. It is alleged that the little fresh water that is available underground will be contaminated during the drilling and fracking processes.
- C. It is alleged that the drilling and fracking processes are also harmful to the environment.

THE FORUM'S POSITION

Our Karoo is a breathtakingly beautiful place, we love it not less than others. Its heavenly fauna and flora and terrific aesthetics have created a lifestyle that defines all of us as its inhabitants. Our love for our Karoo would dictate to us that it's immaculately clean environment must be protected and that protection does not suggest that we must be utopian and believe we live in a pristine place. Any insistence that suggests that any activity that has the slightest risk to the beautiful environment of the Karoo must not be allowed is to imply that the 'pristineness' of the area must be maintained. Karoo is no longer pristine. That is not practical, it is also not desirable. The man's activities in the Karoo and in all other places of our universe have an environmental price. The key question here is to weigh the environmental and social costs of the fracking and determine if it is worth paying the price. In this context the Forum welcomes the decision of our Government to impose a moratorium on the granting of exploration licenses while a multidisciplinary investigation of the environmental implications of such exploration is carried out. We trust that the investigation would enable our Government to soberly assess the potential environmental risks and this should be done in a scientific manner and in accordance with the process laid down in law and not to succumb to the emotional and one dimensional outbursts that have been made in the media and on other platforms. We believe that the potential environmental impacts are manageable and we are confident that our belief shall be supported by the investigation.

The importance of preserving the fresh water in our area cannot be over emphasized. We were therefore extremely concerned about the alleged contamination of water that normally occurs during the drilling and fracking process, but our concerns were adequately addressed by Shell in this case, that its technology does not allow any contact with fresh water during the process.

The Forum nevertheless remains concerned about the huge amounts of water required for drilling and fracking and this is against the background of the serious scarcity of water in the Karoo. We are told that one stage of fracking would require 2.3 million liters of water and a well can have up to 14 fracking stages, which could mean a consumption of 32 million liters of water. Shell alone has applied to drill 24 wells and that could translate into a possible 772.8 million liters of water. We would want to be given a compelling and convincing strategy by Shell on how they intend to import the water as it is clear that Karoo cannot afford to compete with Shell and other applicants for water. We would also like to note that there are also other opportunities, such as recycling waste water.

CONCLUSION

The Graaff Reinet Shale-Gas Forum believes that the potential economic and social advantages of finding substantial reserves of natural gas in the Karoo cannot be overstated. The demand for energy continues to increase in our country and there is no doubt that natural gas has a growing role to play in building a cleaner, more affordable and more secure energy future. Natural gas could also provide South Africa with a stable, sustainable alternative energy source, supporting economic growth, bringing needed employment and economic opportunity in the Karoo. We do not believe that the jobs to be created would come at the expense of others, mainly in the agricultural and tourism sectors. We have no jobs right now! *Ons vrek soos nou!* Two hotels have been closed in the past in Graaff Reinet and that certainly cannot be an indication of a growing tourism.

The Forum would also want to put it on record that it is not in support of the shale gas opportunity at any cost. The concerns raised above must be addressed and most importantly the opportunity must benefit the Karoo communities in the most meaningful way. It is therefore important that a social compact and legally enforceable agreement be put in place to hold the company/companies that are successfully granted a prospecting licence accountable with sufficient monitoring throughout the process with the assistance of legal and environmental professional people.

You will remember that during our work as the Working Group we became aware of the minor seismic events associated with shale gas operations in the UK.

The report by independent investigators was published on 02 November, and I have (1) gone some way to preparing an addendum to the Preliminary Report of the working group, and (2) initiated an enquiry with the seismology unit at CGS. [I have exchanged e-mails with Michelle Grobbelaar who I believe is based in Pretoria]

I now realise that I have got ahead of myself, and that the addendum should more properly be prepared by CGS where specific expertise resides rather than by myself as a geoscientist with general understanding of the issues.
